PLEASE READ AND INITIAL BY EACH OF THE RANGE RULES, THEN SIGN AND DATE AFTER LIABILITY RELEASE.

- 1. Eye and ear protection must be worn at all times.
- 2. Drug and alcohol use is <u>strictly</u> prohibited.
- 3. All rental firearms entering and leaving the range area must be <u>UNLOADED</u> with actions open and gunlock or barrel properly secured.
- 4. Personal firearms must be unloaded and cased, or with current CPL, holstered and concealed, until at station on the range.
- 5. Firearm muzzles must be pointed downrange at all times and NEVER HIGHER THAN TARGET.
- 6. Unaimed and uncontrolled fire is strictly prohibited. All shots must be fired at approved targets. Any shots striking an overhead baffle will result in a \$10.00 fine. Failure to report such an incident may jeopardize your registration with the Range.
- ONLY JACKETED AMMUNITION ALLOWED. No lead or cast bullets may be fired at anytime. (Exception: .22 cal. Rim fire non-jacketed ammo or with prior permission from Firearm Exchange Staff) ABSOLUTELY NO ARMOR PIERCING OR WOLF AMMUNITION ALLOWED.
- 8. RELOADED AMMUNITION MUST HAVE JACKETED BULLETS. Reloads will be inspected prior to use on range.
- 9. Ammo for rental guns MUST be purchased from FIREARM EXCHANGE GUN RANGE.
- 10. Only one person may fire from booth at a time.
- 11. NO RAPID FIRE. 1 round per second.
- 12. <u>NEVER</u> cross the firing line or proceed in front of the barriers.
- 13. NO food or beverages allowed in the Range area.
- 14. Brass may be retrieved from your own area (behind the firing line), but only the amount you brought into the range.
- 15. Please remove and dispose of all debris when leaving the Range.
- 16. Please insure when entering the Range that the outer door is closed prior to opening the inner door for protection of retail customers.
- 17. NO handling of firearms by customers at anytime except when on the firing line at their assigned shooting position or when assisted by range staff. Shooters may trade lanes to try other firearms.
- 18. Any shooter under the age of 18 must be supervised by a parent or guardian and must have proof of completion of a Hunters Safety or Basic Handgun Course. Minimum age is 12 years old.
- 19. ANYTIME A CEASE FIRE IS CALLED, PLACE YOUR FIREARM ON THE BENCH AND BACK AWAY FROM THE FIRING LINE IMMEDIATELY. Any shooter is allowed to call a cease-fire for any safety violation, anytime.
- 20. FIREARM EXCHANGE GUN RANGE employees have UNQUESTIONABLE AUTHORITY regarding the operations of the range.
